

AISSAC-2024: AFTER ROUND-6

INSTRUCTIONS TO THE CANDIDATES (ALLOTTED PROVISIONAL SEAT IN ROUND-6 AND PROVISIONAL WAITING LIST CANDIDATES) APPLIED FOR AISSAC ADMISSION INTO SAINIK SCHOOLS INCLUDING NEW SAINIK SCHOOLS

1. The result for Round-6 of e-Counselling will be declared by Sainik Schools Society on the AISSAC- 2024 portal on 01 August 2024 (AN).
2. All candidates who are allotted seats provisionally in Round-6 are requested to opt “ACCEPT” / “REJECT” / “EXIT”/ “CLOSE PORTAL” as per projected timelines. “Reconsider” option will not be available in Round-6 as there will be no further Round of centralised e-Counselling. The options available to the candidates are explained below: -
 - (a) **ACCEPT**. If a candidate accepts the allotted seat, then it will be presumed that he/she is satisfied with the school allotment, and he/she has to complete admission formalities (Medical cum Physical Documents Verification) within the prescribed time. If a candidate does not ‘Accept’ the allotted seat within the specified time, then the candidate will not be given any further opportunities to join the allotted Sainik School based on the score of AISSEE- 2024. However, such candidates may be offered seats as mentioned in Para 4(c) and 4(d) below. Those who ‘ACCEPT’ the allotted seats will follow the steps as enumerated in Para 4 (f), (g) & (h).
 - (b) **REJECT**. If a candidate is not satisfied with the seat allotted, he/she can opt for the ‘REJECT’ option to participate in the next round of offline counselling for the remaining leftover seats. However, in doing so, the allotted seat shall be automatically cancelled and no further claim will be admissible. Furthermore, if the candidate selects this option, the school allotted to candidate in the present round, would no longer be available as an option to candidate in subsequent offline rounds.
 - (c) **EXIT**. If a candidate selects the ‘EXIT’ option, then it will be considered that the candidate is opting out of the counselling process and further candidate will not be able to participate in any round of offline counselling or claim admission in any school based on AISSEE-2024 merit. Candidates who do not react to the allocated seat in any Round will be allotted EXIT option automatically by the system and further, such candidates CANNOT participate any more in Seat Allocation for the ensuing academic year 2024-25.
 - (d) **CLOSE PORTAL**. If a candidate selects the ‘CLOSE PORTAL’ option then it will imply that the candidate is closing the web portal momentarily. This option would not entail “Accept” of allotted school or “Reconsider” option or “Exit” option by the candidate. This option is provided to candidate, who are not able to decide amongst ACCEPT/REJECT/EXIT option and would like to log out of the portal.
3. The name of the candidates who are allotted the school in Round-6 may also figure in the Provisional Waiting List of other Sainik Schools. However, there is no guarantee that such candidates in the Provisional Waiting List of other schools will be offered admission since it will depend on ‘Merit List’ prepared by the school as per policies/guidelines/instructions issued by Sainik Schools Society (MoD), the available vacant seat/s in the respective school in a particular category and Order of Merit of candidate for that school.
4. It may be noted that choices once filled and ‘Locked’ in Round-6 has been considered as the final choice for allotment of Sainik Schools/ New Sainik Schools by the candidate and for the preparation of the Provisional Waiting List(PWL). No request for a change of choices will be accepted thereafter.
5. Parents/ Candidates are advised to check the information about the allotted school in Round-6, if allotted by the AISSAC-2024 portal. They may contact the school /visit the website of the school before taking action on the AISSAC-2024 portal. Information about all the schools is available on <https://pesa.ncog.gov.in/sainikschoolecounselling/SchoolInformationURL>. For further guidance, candidates may refer to AISSAC-2024 SOP at <https://pesa.ncog.gov.in/sainikschoolecounselling/GuidelineSop>.

6. No requests will be entertained by the SS Society in case of a mistake in choosing the wrong option of "ACCEPT" buttons in the dashboard of AISSAC-2024 portal of candidate, as the same will be confirmed 05 times from the candidate before final confirmation by the portal.

7. A candidate who in Round-6, has been allocated and choose "ACCEPT" (within the last date) a seat at any allotted Sainik School/ New Sainik School should download a pdf and take the printout of the Provisional Allotment Letter Generated through the system. Subsequently, he/she must complete admission formalities comprising Medical cum Physical Verification of documents within the prescribed time as given in the portal. The list of documents along with the format is available at <https://pesa.ncog.gov.in/sainikschoolecounselling/DocumentDetailsUrl>. Failing to report in person within the specified time window, the seat allocated to the candidate will automatically be forfeited and the candidate will be rejected.

8. The candidate accepting the allotted school needs to follow the steps given below: -

(a) **STEP-1- REPORTING AT MEDICAL CENTER.** After acceptance of the seat, candidates will have to report at the Medical Examination Center as per the Slot given by the allotted school. It is the Parent's / Guardians responsibility to get the medical done in respect of their son/daughter. However, the school will provide help to the candidates in coordinating with Medical Authorities, in case of any problem faced by the parents. **For existing Sainik Schools the format of the medical form will be available on the AISSAC-2024 portal. For the approved New Sainik Schools, the candidates will get a Medical Fitness Certificate from a registered Government physician as per the directions of the allotted New Sainik School.**

(b) **STEP-2- PHYSICAL VERIFICATION OF DOCUMENTS BY ALLOTTED SCHOOL.** After the medical fitness report, candidates will have to report to the respective school and produce all required documents to the admitting school. The admission will be cancelled if these candidates fail to meet the requirements as per the prevailing norms. Therefore, it is the responsibility of the candidate to produce only valid certificates and documents for scrutiny by the school. All the certificates / documents will be verified at the time of Physical reporting at the admitting school.

(c) **STEP-3- PAYMENT OF FEE.** After completing the above two steps and any other admission formalities of the admitting school, the candidates should pay the fees and get the admission confirmed. Kindly contact schools in advance for fee information through the link <https://pesa.ncog.gov.in/sainikschoolecounselling/SchoolInformationURL>.

9. **Instructions for the Provisional Waiting List candidates.** The Merit List for offline rounds of each Sainik School / New Sainik School will be available on respective Schools website (on 14 Aug 2024) after Round-6 of e-Counselling is completed.

(a) Merit list/s will be prepared and uploaded on their websites by the schools based on the available vacant seat(s) in the respective school (after Round-6 admissions) in a particular category out of the Provisional Waiting List as per policies/guidelines/instructions issued by Sainik Schools Society, MoD.

(b) It is possible that the name of a candidate may figures in more than one School. Candidates are advised to take an informed decision before accepting admission offered by any of the allotted School.

(c) It may be noted that the transfer of a candidate to another School even if offered at a later stage is not permitted once admission has been taken in 'Accepted' School.

(iv) Schools will also contact candidates who would appear in school's Merit List from the Provisional Waiting List. Candidate (whose name appearing in school Merit List) "Accepting" school admission offer will have to complete admission formalities comprising Medical cum Physical Verification of documents within the prescribed time as issued by the school failing which candidate will be rejected.

10. After Round-6 of centralised e-Counselling, the schedule for declaration of Merit List and conduct of e-Counselling would be as follows: -

Note -

- 1. It is the candidate's responsibility to plan their travel such that the Medical (including Review medicals) cum physical verification of documents is completed by the last day of the counselling round in which they are allocated a seat (if any). No exceptions shall be made in this regard.***
- 2. Candidates should approach their allotted school for any guidance required during the process of admission within timelines as provided on the AISSAC- 2024 portal.***
- 3. Once the candidate is Rejected by the allotted school due to any reason, he/she will be out of the e-Counselling process, and he/she can't claim admission in any remaining school based on AISSEE- 2024 merit.***
- 4. The mere appearance of the candidate's Roll No in the Provisional Waiting List of the school does not guarantee admission of the candidate in the respective School.***

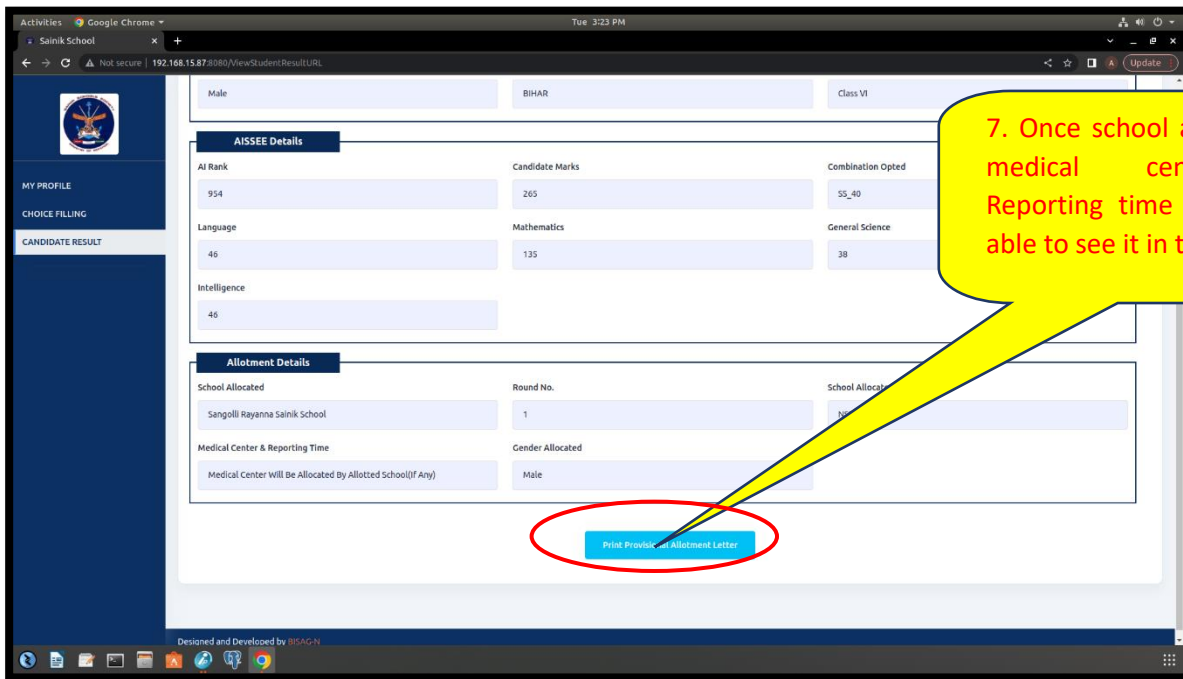
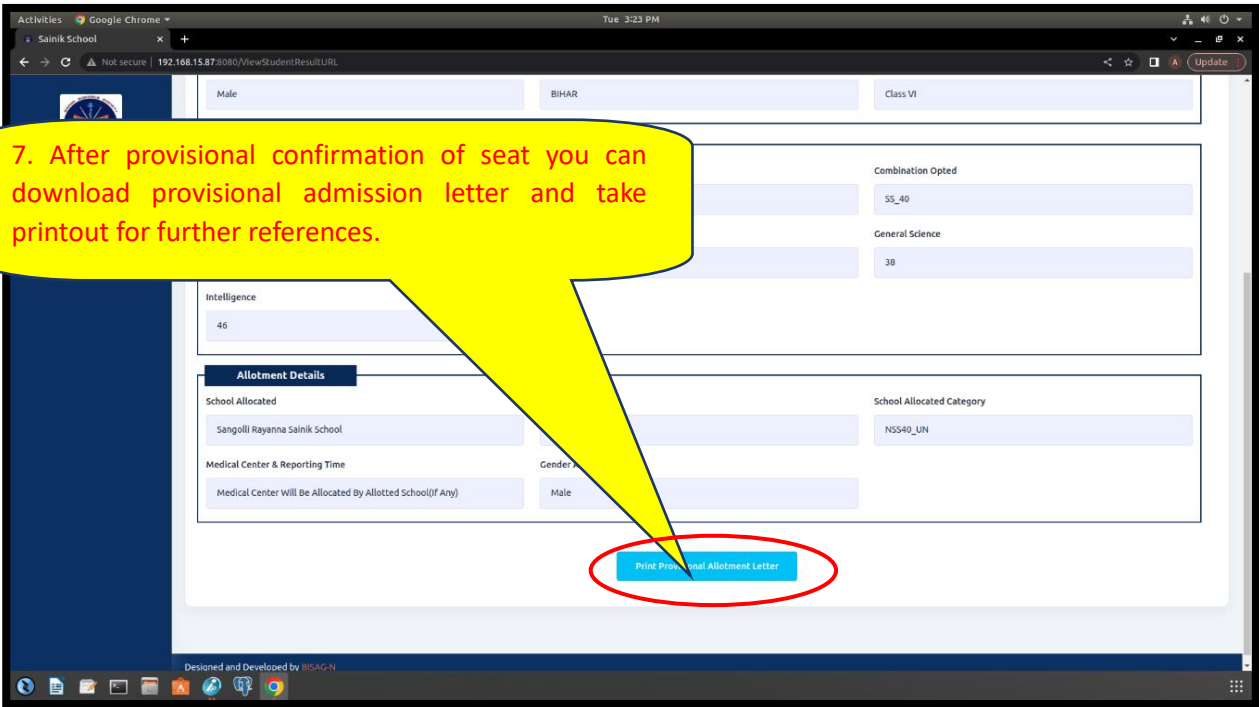
4. Once you will click Accept and Continue, you will get 5 confirmation pop-ups with message for confirmation.
